Applicant assumes full responsibility for complying with all regulations and requirements under which construction is contemplated. All work shall be done in accordance with the approved plans which shall be retained by the Inspector and on site at all times while work is in progress. This permit shall become null and void if work is not completed within 180 days.

It shall be the duty of the applicant to notify the Inspector that such work is ready for inspection and to provide access to and means for such work. Work shall not be done on any part of the building or structure beyond the point indicated in each successive inspection without first obtaining the Inspector's approval. Upon **failure of the second inspection of the same work, a \$42.00 reinspection fee, to be paid upfront, will be applied for each inspection thereafter.**

Required Submittals with Permit Application:

- Evidence that property is properly platted & surveyed by licensed professional
- Legal description of property
- Four sets of engineered building/construction plans
- Any special plans to include sidewalks, parking/driveways, landscaping, fencing, etc.

Additional Information & Requirements

Payment of permit fees does not authorize work to be started until the permit card has been received from the inspections department. The permit card must be posted in a conspicuous place on the job site.

The building **shall not be occupied until a certificate of occupancy has been issued.** Performance of work **must follow minimum standards as established in the 2000 IBC, IMC, IPC, IFC and 99 NEC.** Please remember to **call 24 hours in advance** to schedule inspections to be completed.

A qualified, licensed craftsman must perform electrical, plumbing and mechanical work, and must be licensed by the City of Excelsior Springs, Mo.
